Additionally, Mr. Pigott served as Treasurer and then President of the East Texas Gas Producers Association from 2001-2002. Company Overview

Anadarko Petroleum Corporation is among the world's largest oil and natural gas exploration and production companies; with 2.54 billion barrels of oil equivalent (BOE) in proven reserves at year-end 2011. Our deep and balanced portfolio of assets encompasses premier positions in major U.S. onshore shale and resource plays, and oil-focused opportunities in deepwater basins worldwide.

Specifically, in East Texas and North Louisiana, Anadarko holds approximately 165,000 net acres and operates approximately 1,300 operated wells in the Carthage, Henderson, Oak Hill and Elm Grove Fields located in Panola, Harrison, Rusk and Gregg Counties, and Bossier and Caddo Parishes, which were historically drilled vertically for liquids-rich Pettit, Travis Peak and Cotton Valley reservoirs. Currently, Anadarko is an industry leader in the efficient horizontal development of the Cotton Valley and Hayneville reservoirs. The company has existing expanded midstream upon infrastructure to facilitate the tremendous growth realized in 2012 by means of integrated project management. In 2012,

Anadarko increased sales rates more than 80% by bringing on line 60 new horizontal wells in this area. The company also has maintained a strong focus on managing its base production decline and has reduced lease operating expenses by more than 40% per barrel of oil equivalent (BOE). Environment, Health and Safety remain top priorities and led to the asset team achieving 1.1 million man hours without a lost-time accident in 2012.

Through pad drilling, service provider renegotiations, design optimizations and water management, Anadarko has been able to safely reduce well drilling and completion costs by nearly 50% since the beginning of the horizontal program; thus, greatly improving economics.

Anadarko exited 2012 with sales volumes above 50,000 net BOE per day in East Texas and North Louisiana and plans to continue operating seven rigs to develop liquids-rich Cotton Valley and Haynesville horizontal wells in 2013.
